### **FEDERATION MEMBERSHIP APPLICATION**

A **Federation Member of HETI** is defined as an organization or federation practicing or promoting therapeutic equestrian activities, which fulfill the requirements for membership described on the next page. A complete listing of membership benefits can be found on [www.HETIfederation.org](http://www.HETIfederation.org).

**FEDERATION MEMBERSHIP** is open to National Organisations practising therapeutic equestrian activities, which fulfill the requirements for membership. Authority to confer such membership is vested in the HETI International Council.

**FEDERATION MEMBERS** have the right to nominate one of their members to become members of the International Council if elected within their own country as one of the National representatives. They also have the right to nominate one of their members to stand for election as one of the Officers of HETI or to the Executive Board.

### **RESPONSIBILITIES OF FEDERATION MEMBERSHIP**

1. A Federation member organization is a legally constituted body in its own country and endorses the statement of purpose as written in the HETI constitution and agrees to abide by any rules and by-laws established therein regarding the relationship between the HETI and its member organizations.
2. A Federation member organisation is responsible for the payment of the annual membership fee on a regular and timely basis.
3. A Federation member organisation is permitted to indicate its affiliation with HETI on publications, stationery and other literature provided that it does not imply either directly or indirectly that HETI endorses in any way or vouches for the quality of service rendered, safety or medical effectiveness of the member organisation's services.
4. A Federation member is prohibited from claiming either directly or indirectly that it speaks on behalf of HETI unless specifically authorised to do so in writing by the President or Secretary General.
5. The Federation member organisation pledges involvement in and positive support of HETI's organisation, administration and activities.
